For service in the Guam - Saipan Digital Fiber System, the following rates will apply for 1 - 5 year term subscription and circuit capacity as shown. No nonrecurring charge. If the customer terminates service prior to the completion of the term subscribed, a termination penalty as described below shall apply.

Termination Penalty

A Termination penalty shall be applied if the service is canceled prior to the end of the commitment period. The applicable penalty shall consists of:

- (a) flat termination penalty of \$150 plus,
- (b) a monthly rate and the rate paid times by the number of months service was subscribed plus,
- (c) a 1% interest per month on the monthly rate adjustment.

For purposes of this calculation, a fraction of a month shall be considered a whole month. Thus if the customer terminates service after 14 months and 5 days, this portion of the penalty will be calculated based on 15 months.

Example:

If the customer subscribes to a 128 Kbps full circuit capacity for 3 years and terminates the service after 18 months 7 days, the penalty will be calculated as follows:

Flat termination penalty \$ 150.00

Monthly rate adjustment calculation:

1-Year 128 Kbps Monthly Rate \$1,868.00  
3-Year 128 Kbps Monthly Rate 1,804.00

Difference \$ 64.00  
Applicable Months 19

Monthly Rate Adjustment 1,216.00

Interest calculation:

Monthly Rate Adjustment \$1,216.00  
Monthly Interest factor (note) .09

Applicable interest 109.44

Total Termination Penalty \$ 1,475.44

Note: Interest for the first month will be \$64 x 18 months x 1% \$11.52. No interest will be assessed on the last month of subscription.
